Our High Hopes Scholarships Program provides motivated low-income, first-generation college students with direct financial support of \$500 - \$2,000 per semester. Scholarship funds are used to pay for college tuition, books, fees, and other educational expenses. The program also provides one-on-one support from a College Success Advisor to help each scholar navigate financial, academic, and emotional challenges encountered during their time in college. Each scholar enrolled in a bachelor's degree program is also paired with a volunteer mentor to give advice and encouragement, as well as introductions to possible career networks and opportunities. As of FY2019, 86% of our scholars have succeeded in earning a bachelor's degree or are persisting in their work towards a degree.
